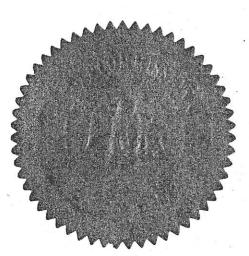

### ARTICLES OF INCORPORATION

The undersigned natural person, over the age of twenty-one (21), or more, acting as incorporator under the provisions of the New Mexico Nonprofit Corporation Act (hereinafter referred to as the "Act") hereby adopts the following Articles of Incorporation.

# Article I Name of Corporation

The name of this corporation is Los Cerritos Area Homeowner's Association, Inc. (hereinafter referred to as the "Corporation").

Article II Duration

The duration of this Corporation is to be perpetual.

Article III Purposes and Powers

SECTION 1. Purposes. The purpose for which this Corporation is formed is to operate, maintain, and mange Los Cerritos roads, open spaces and to conduct such other activities as are customary and necessary for a homeowners association.

SECTION 2. Powers. In furtherance of and not in limitation of the purposes hereinbefore stated, it is expressly provided that the Corporation organized for the purpose of engaging in any lawful act or activity for which nonprofit corporations may be organized under the Act.

### Article IV Stock

This Corporation is not organized for profit and shall no capital stock.

# Article V Internal Affairs

This nonprofit corporation shall be governed by a Board of Directors which shall be elected by the owners of the lots which comprise "Los Cerritos" in accordance with the Bylaws which may be adopted or amended from time to time. Upon dissolution or liquidation of this nonprofit Corporation, the assets shall be applied and distributed as follows:

- A. All liabilities and obligations of the Corporation shall be paid and discharged, or adequate provision shall be made therefore;
- B. Assets held by the Corporation upon condition requiring return, transfer or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred or conveyed in accordance with such requirements;
- C. Assets received and held by the Corporation subject to limitations permitting their use only for nonprofit purposes, but not held upon a condition requiring return, transfer or conveyance by reason of the dissolution, shall be transferred or conveyed to one or more nonprofit domestic or foreign corporations engaged in activities substantially similar to those of the dissolving corporation, pursuant to a plan of distribution adopted as provided in the Nonprofit Corporation Act of New Mexico, as it may be amended from time to time;
- D. Other assets, if any, shall be distributed in accordance with the provisions of the Bylaws, but in no event may any member, former member, director, former director, officer or former officer receive directly or indirectly any distribution or portion of a distribution of any assets; and
- E. Any remaining assets may be distributed to such persons, nonprofit societies, nonprofit organizations or nonprofit domestic or foreign corporations whether for profit or nonprofit as may be specified in a plan of distribution adopted as provided in the Nonprofit Corporation Act of New Mexico as it may be amended from time to time.

### Article VI

# Registered Office and Registered Agent

The address of the registered office of the Corporation is 200 Central SE, Moriarty, New Mexico 87035-0978. The name of the initial registered agent of this Corporation is Timothy R. Oden, 200 Central SE, Moriarty, New Mexico 87035-0978.

# Article VII

### Board of Directors

The affairs of the Corporation shall be conducted and managed by a Board of Directors composed of not less than three (3), not more than fifteen (15) directors as established by the Bylaws, to be elected by those entitled to vote as such election, in the manner and for terms provided by the Bylaws. The number of directors constituting the initial Board of Directors of the Corporation is four (4) and the names and addresses of the persons who are to serve as the initial Board of Directors are as follows:
